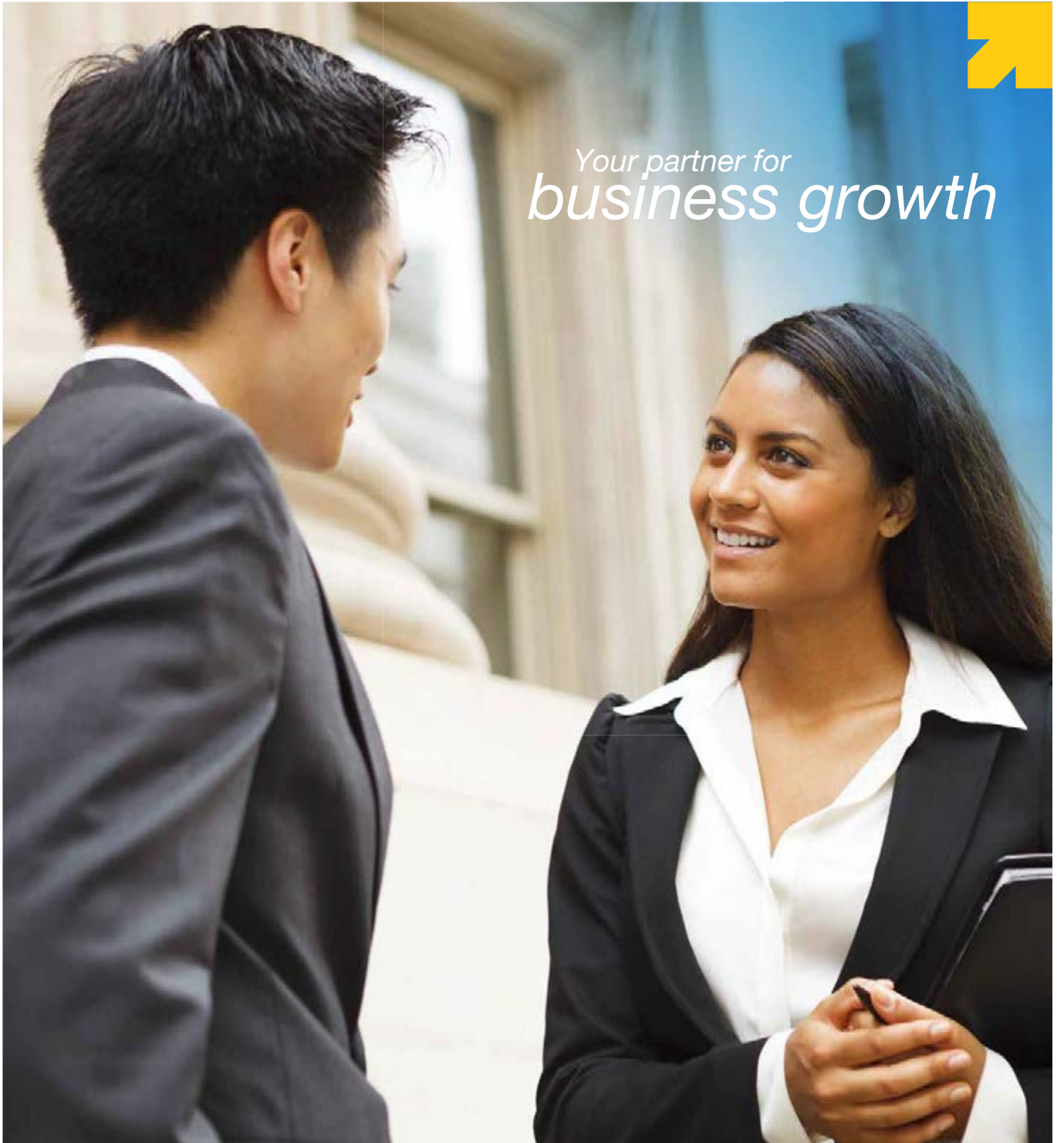

What encouraged you to enter politics?

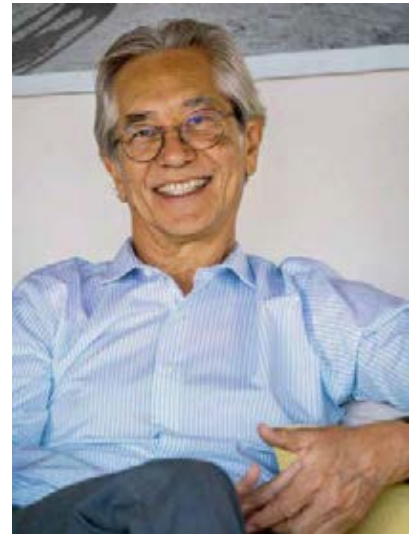
The most rewarding part of my role is building bridges between Mauritius and China while rediscovering its rich culture

What has been the most rewarding part of your role as Mauritian Ambassador to China so far?

The most rewarding aspect is the privilege of building bridges across the 5Cs of Connectivity - Air, Sea, Digital, Economic, and People-to-People - while rediscovering a country I have travelled through for over 25 years. Yet it is more than discovering a country; it is discovering a civilisation - one of extraordinary depth, resilience, creativity, and continuity. Returning to China in an official capacity allows me to reconnect with long-standing friendships, academic networks such as Tsinghua University, and the cultural and intellectual richness that have shaped my understanding of Asia. Engaging with the 175 embassies represented in Beijing adds another layer of inspiration, making this mission uniquely stimulating and globally relevant.

What inspired you to take up this diplomatic mission?

My inspiration comes from decades of travel, collaboration, and admiration for China's dynamism. For 25 years, I have witnessed China's remarkable transformation - its architecture, creativity, technological progress, and cultural resilience. This mission allows me to bring together my passions for architecture, diplomacy, sustainability, and global cooperation. The opportunity to serve Mauritius at a time when connections between Asia and Africa are becoming geopolitically essential felt natural — an extension of a lifelong journey of building bridges.



How would you describe the current relationship between Mauritius and China?

Our relationship is deep, respectful, and anchored in long-term friendship. Today, it is strengthened by shared aspirations in trade, innovation, sustainability, people-to-people exchanges, and cultural cooperation. We also see renewed momentum: discussions on restoring air connectivity, expanding investment, advancing (Free Trade Agreement) FTA 2.0, and enhancing trade and tourism flows. In a world of shifting global currents, the Mauritius–China partnership stands out as stable, constructive, and strategically promising.

What areas of cooperation do you see strengthening in the coming years?

Several high-value areas will continue to deepen:

- Air Connectivity - a strategic priority with transformative impact.
- Digital Transformation & AI - digital twin applications, cloud services, fintech, cybersecurity, e-commerce.
- Climate Resilience & Green Transitions - renewable energy, blue economy, carbon markets, water management.
- Higher Education & Research - strengthening academic ties with institutions such as Tsinghua University and others.
- Healthcare & Biotechnology - diabetes research, pharmaceuticals, medical innovation.

- Culture & Creative Industries - Mauritian multiculturalism resonates strongly with Chinese audiences.

These areas align naturally with the national strategies of both countries.

Which sectors offer the most promising opportunities for Mauritian and Chinese businesses?

For Chinese investors in Mauritius:

- Logistics & Freeport — Mauritius as the most efficient gateway to COMESA, SADC, and AfCFTA.
- Digital & AI Services - cloud, cities, fintech, digital twin technologies.
- Green & Blue Economy - renewable energy, waste-to-energy, ocean economy, AI agriculture
- Specialised Manufacturing - leveraging African preferential access.
- Tourism & Real Estate - eco-resorts, hospitality development, smart city projects.
- The Jin Fei Special Economic Zone redevelopment, a multi-billion-dollar opportunity for next-generation industrial and innovation clusters.

For Mauritian companies in China:

- Premium food products - seafood, rum, niche agricultural products.
- Tourism & Education promotion - a massive outbound market (island honeymooners) with strong interest in multicultural destinations.
- Creative and cultural industries - design, publishing, boutique brands.
- Professional services - sustainability consulting, financial services.

What upcoming initiatives or projects between our two countries are you most excited about?

I am particularly excited about:

- The restoration of direct flights between Mauritius and China, a regional game-changer.
- The revitalisation of the Jin Fei Special Economic Zone, positioning Mauritius as a hub for innovation, logistics, digital services, and renewable energy.

- The establishment of a Mauritius Pavilion in Yiwu and other provinces, boosting Mauritian exports and creative industries.
- New partnerships in education, cultural exchange, digital innovation, healthcare, and green technology.
- Advancing our economic partnership through FTA 2.0.
- Strengthening institutional links with universities such as Tsinghua, Tongji reconnecting with long-standing intellectual and professional networks in China.

Each initiative opens new pathways for sustainable, mutually beneficial growth.

What do you enjoy most about living or working in China?

China is endlessly fascinating. After 25 years of travelling across its regions, I continue to marvel at how ancient traditions, philosophical depth, and cutting-edge innovation coexist. Living in Beijing today — at the centre of a diplomatic community — offers a unique vantage point on global trends and international cooperation. The pace of innovation, the warmth of its people, and the diversity of its landscapes make every day an enriching experience.

Do you have a favourite Chinese city, food, or cultural experience you would recommend?

After two decades of travel, several cities are close to my heart:

- Beijing - a masterpiece where history, culture, and modernity converse constantly.
- Shanghai - a magical city, where the pulse of global finance meets Art Deco heritage, futuristic skylines, and boundless creativity
- Xi'an - the cradle of the Silk Road and a living testimony to global connectivity.
- Hangzhou - where nature, beauty, and innovation coexist in harmony.
- Jinhua-Yiwu - a world-class engine of e-commerce and entrepreneurial energy.

Culturally, I always recommend a traditional Chinese tea ceremony - a moment of refinement, serenity, and profound cultural symbolism.

Eric NG PING CHEUN

With the cooperation of all stakeholders, the country will be able to overcome these difficult times



How would you describe the current economic situation in Mauritius?

The new government has inherited a very dire economic situation with public finances in shambles. In view of the high budget deficit and the high public sector debt, the government's first priority was to put order in public finances. The economic and fiscal measures that it has taken have played a key role in helping Mauritius maintain its investment-grade status under Moody's credit ratings. This achievement has strengthened confidence in the country's financial sector, leading to renewed investor trust.

Despite the lingering effects of the economic mismanagement of the previous government, GDP growth is projected to remain above 3.0 per cent in 2025. The unemployment rate has declined to 5.6 per cent in the third quarter of 2025 from 5.9 per cent in the corresponding quarter of 2024, with employment of Mauritians increasing by 9,000 to 556,400. The headline inflation rate has remained below 4.0 per cent for the year 2025. Gross official international reserves rose to USD 10.3 billion at the end of 2025, representing 14.3 months of import cover. And tourist arrivals have reached a record of 1,436,250 for the year 2025.

What are the main challenges the Mauritian economy is facing today?

Our main challenge is to stabilise the exchange rate of the rupee following the massive depreciation of the local currency over the past 10 years. Several measures have been taken by the Bank of Mauritius in this regard, while its independence in formulating and implementing monetary policy has been reinstated. True, the rupee has recently benefitted from the weakening of the US dollar on the international market.

In the long run, we cannot just rely on the interventions of the central bank on the domestic market. The country needs to revamp its export sector, targeting both goods and services, and to attract more foreign direct investment. Reducing the trade deficit and financing it with a capital account surplus are a big challenge.

Precisely, how is Mauritius working to attract more foreign investment?

We do not have a problem of attracting foreign direct investment (FDI), but the issue is how to bring about a sectoral diversification of FDI in Mauritius. More than two thirds of FDI flows, lured by generous fiscal incentives, go to the real estate. The government's strategy is rather to get more FDI in productive activities, namely

industrial manufacturing as well as financial and professional services, which would bring tangible benefits to the national economy. To achieve this objective, the Economic Development Board has established some key performance indicators. Above all, there must be greater synergy between the EDB, the ministries, the local government and the various public agencies to speed up the approval process for investment projects.

Which sectors do you believe have the strongest growth potential?

The 2025-2026 Budget has identified five new growth poles: the green economy, the blue economy, the circular economy, the agro-industry and the adoption of artificial intelligence and disruptive technologies. The country needs to diversify its industrial base while consolidating its service activities. Projects worth Rs 30 billion in the renewable energy sector will be implemented in the next three years. There is a huge potential in fostering a sustainable and inclusive economy and in promoting food and energy security, decarbonization of the economy and digitalization of the public services and of all economic activities.

What measures is the government prioritising to support economic development?

A high-level steering committee has been set up under the chairmanship of the Junior Minister of Finance, Dhaneshwar Damry, with representatives of the private sector to follow up on the measures announced in the government programme. Emphasis is being laid on removing administrative bottlenecks in order to accelerate investment projects. Applications for work permits will also become less burdensome with a fast-track and simplified rules-based system. Moreover, port infrastructure is high on the agenda as the government is aiming at boosting exports and at developing the ocean economy. Last, but not least, public sector reforms are more than necessary to propel the country on a higher plane of economic development.

How is Mauritius preparing for future global economic uncertainties?

Mauritius is facing economic uncertainties such as the independence of the Fed, the on-again off-again approach of the Trump administration to international trade, the ongoing war in Ukraine and geopolitical tensions in several parts of the world. These have direct and indirect impacts on the Mauritian economy. It is therefore essential for the country to build economic resilience through structural reforms and creating fiscal space that will help withstand external shocks.

With a view to restoring sound fiscal stewardship, the government has embarked on a bold fiscal consolidation plan combining enhanced revenue mobilisation, prudent expenditure management and improved public-sector efficiency. A number of measures have already been implemented to ensure that public funds are used in such a way as to maximise economic benefits and minimise inefficiency. The Performance-Based Budgeting system has been re-introduced to systematically link funding with results and outcomes and to help reduce wastage; and the number and functions of public bodies have been rationalised.

What message would you like to share with the business community?

The government is determined to redress the public finances and to fix the economy. I would ask the business community to bear with the government while bringing its fair share contribution to that endeavour. With the cooperation of all stakeholders, the country will be able to overcome these difficult times.

The most common misconceptions relate to range, cost and charging. In reality, daily driving needs in Mauritius are well within the range of modern EVs. While EVs may appear more expensive upfront, long-term savings on fuel and maintenance are substantial. As for charging, infrastructure is expanding rapidly, both at home and in public spaces.

How do you ensure strong after-sales support for EV customers?

We have invested heavily in certified EV technicians, advanced diagnostic and connected tools, as well as strategic local stock of critical parts and batteries. This allows us to deliver reliable, efficient and long-term after-sales support.

How do photovoltaic solutions fit into your overall strategy?

Photovoltaic solutions are a natural extension of electric mobility. Since 2013, we have been delivering high-quality turnkey PV systems designed for durability and performance. Our solutions include smart monitoring, optimisation and energy storage, and are backed by strong international technology partnerships, excellent warranty conditions and competitive pricing. Most importantly, we offer a complete ecosystem that connects home energy, EV charging and storage.



How do you see the market evolving over the next five years?

We expect continued growth in EV and hybrid adoption, alongside more digitalised and connected mobility experiences. Key opportunities include corporate fleet electrification, integrated PV and mobility packages for SMEs, and the development of predictive maintenance and connected services.

What are your strategic priorities and upcoming innovations?

Our priorities are clear: diversification into EVs, PV and integrated services, delivering a premium customer experience, and continuously strengthening our technical capabilities. Looking ahead, we will introduce new BMW, MINI, BYD, KIA and GWM EV models across our brands, smart charging solutions, more digitalised after-sales services, and bundled PV and mobility offers.

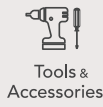

Strengthening Connections: How the CBC Benefits from its UCA Affiliation

Since 2017, the Chinese Business Chamber (CBC) has been a founding affiliate of the United Chinese Associations (UCA), the largest federation of Chinese associations in Mauritius and Rodrigues. Bringing together 33 affiliates - including one from Rodrigues - and representing over 5,000 members through its associations, UCA serves as the principal platform for cultural preservation, social cohesion, and community development within the Sino-Mauritian community.

UCA's affiliates include long-established organisations such as the Heen Foh Lee Kwon Society, the Hua Lien Club, senior citizens' associations, and other key community groups. To date, CBC remains the only affiliate representing the corporate sector. Notably, when UCA was founded, CBC's representative was elected to lead the federation, with CBC Past President Eddy Tong Sam serving as UCA's first President in 2018.

Since 2025, CBC has been represented at UCA by Vice President Angelie Ng Thow Hing, a CBC Board Member since 2019 who has served as Treasurer, Secretary, and Vice President, bringing valuable governance experience to her elected role at UCA.

On 27 March 2025, for the first time in a quarter of a century, the Chinese Business Chamber (CBC) has secured representation on the Board of the Mauritius Chamber of Commerce and Industry (MCCI), a landmark achievement signalling deeper integration within Mauritius's premier business advocacy body. This historic seat, reserved for a CBC Board Member, is now held by Immediate Past President, Mr. David Koon kam King, providing the Chamber with a front-row perspective into the operational sophistication and influential machinery of the nation's largest business consortium.

The CBC has gained critical insights into the MCCI's robust infrastructure and how it champions its members' interests. This is demonstrated in the MCCI's proactive lobbying on pivotal national issues: from shaping the annual Budget Memo through extensive sectoral consultations, to navigating complex regulatory landscapes like the moratorium on single-use plastics and the implementation of the sugar tax. The MCCI's approach is not reactive but strategic, employing technical committees, commissioning studies, and engaging in sustained dialogue with government ministries to steer policy outcomes.

Central to this efficacy is a dedicated professional secretariat led by a full-time Secretary-General. This permanent executive arm, exemplified by Dr. Drishty Ramdenee's role in the essential continuity, research, and administrative backbone that transforms the board's directions into actionable advocacy. It operates as the engine room, supporting the elected leadership—such as President Charles Harel—who provides the strategic direction and high-level engagement.

Examples of Issues Discussed by MCCI and Their Outcomes

- International Trade Agreements: Advocated Mauritius's interests in key trade deals. Progress achieved on the Interim EPA with the EU (nearing conclusion), UAE CEPA entered into force on 1 April 2025 with member sensitisation planned, active lobbying for AGOA renewal ahead of September 2025, and engagement on AfCFTA rules of origin, with reviews postponed to 2027.
- Plastic Management: Secured a one-year extension of the moratorium on selected single-use plastic food packaging items to January 2026, participated in the Plastic Management Committee, and maintained calls for exemptions for pre-packed food.
- Budget Advocacy: Conducted sector consultations and submitted the MCCI Budget Memo 2025/26, followed by post-budget debriefs and a supplementary memo.
- Sugar Tax: Highlighted implementation challenges; expansion was delayed but not prevented.
- Food Regulations 2024: Successfully obtained a six-month extension for new labelling requirements and continued technical engagement.

Establishing Operations in Mauritius to Bridge Africa and the United States

In the dynamic landscape of global finance, where capital seeks both stability and opportunity, selecting an operational base requires strategic foresight. At Stewards, we have consistently prioritized the development of robust investment structures that integrate local knowledge with international networks to create sustainable value. This commitment has led us to establish our presence in Mauritius, viewing it not merely as a secure foundation but as the optimal conduit for connecting Africa's emerging growth prospects with the strength of the United States economy.

Our decision to base operations in Mauritius is deliberate, grounded in its established advantages as an International Financial Centre (IFC). The nation features a strong economic framework, characterized by prudent fiscal policies and a diversified portfolio of sectors, including finance, technology, and tourism, which support steady expansion. The 5.1% GDP growth recorded in 2024 exemplifies this durability amid international economic fluctuations. Geographically, Mauritius is strategically situated at the intersection of Africa and Asia, with affiliations to key regional organizations such as the Southern African Development Community (SADC), the Common Market for Eastern and Southern Africa (COMESA), and the African Continental Free Trade Area (AfCFTA), thereby facilitating access to extensive markets.

These benefits are reinforced by tangible incentives, including a network of 53 double taxation avoidance agreements (22 with African nations) and 44 investment promotion and protection agreements (25 focused on Africa). These instruments extend beyond formalities, offering reduced risks, complete foreign ownership, unrestricted capital movements, and straightforward repatriation of profits. Combined with Mauritius' stable political environment, a leading African democracy in terms of governance, economic freedom, and peace. This creates a setting conducive to long-term strategic planning without undue disruptions.

Our conviction extends further: Mauritius is positioned to emerge as the primary IFC for fostering connections between Africa and the United States. It has already directed over \$150 billion in foreign direct investment (FDI) into Africa over the past decade and is now expanding this role transatlantically. Through our operations across Mauritius, South Africa, and the United States, we are actively realizing these linkages. For instance, our Stewards Private Credit Fund, which grew from \$30 million in early 2025 to \$207 million by end of year is proof of our conviction.

This efficacy stems from Mauritius' adherence to international standards, including those set by the OECD, EU anti-money laundering directives, and FATF recommendations, which foster credibility and confidence.

Looking to the future, the Nasdaq listing of our U.S. affiliate will enhance these interconnections, attracting additional institutional participants and expanding transaction volumes. We intend to continue our growth in Mauritius, collaborating with regulatory authorities to extend our licensed activities.

Although modest in size, Mauritius possesses immense potential. By capitalizing on its stability, comprehensive treaties, exemplary regulations, and innovative capabilities, it is destined to serve as the vital nexus between African aspirations and American investment. At Stewards, we are privileged to contribute to this evolution, generating enduring prosperity that spans continents.

Budget 2023 – 2024

7 June 2023



Mr. Ramdin from the MRA, along with Mr. Balloo from KPMG, presented an overview of the tax implications arising from the budget. Highlights included mandatory smart POS systems and e-invoicing linked to the MRA to reduce paperwork, implemented progressively from large firms. The solidarity tax was abolished in favour of a fairer progressive system. Other measures covered tax incentives, green mobility, childcare requirements for large employers, higher property duties, and a review of the tax appeals process.

Business trip to Malaysia

29 June to 11 July 2023



As President, David Koon Kam King led a delegation of 10 CBC members on a business mission to Malaysia, covering Kuala Lumpur and Kuching. During the visit, the delegation met three major business chambers representing more than 100,000 members. In Kuala Lumpur, the CBC engaged with companies operating in timber exports, plant-based noodles, plastics, construction materials, tissue and wipes, palm oil, and related sectors. Strong links were established with the Associated Chinese Chambers of Commerce and Industry of Malaysia (ACCCIM), one of the country's largest Chinese business chambers, as well as with its dynamic Youth Committee.

The delegation also attended the Food and Drinks Malaysia 2023 exposition, discovering industry innovations and meeting a venture capital firm specialising in food investments. Discussions were held with the Ambassador of Mauritius to Malaysia, Mr. Jugdish Goburdhun, on visa matters and trade opportunities. In Kuching, the CBC attended the 133rd anniversary of the Kuching Chinese General Chamber of Commerce and Industry and met business chambers from across the region, as well as the Premier of Sarawak and the Minister of Tourism.

CBC Meets Minister of Commerce to Address Key Member Concerns

31 January 2024

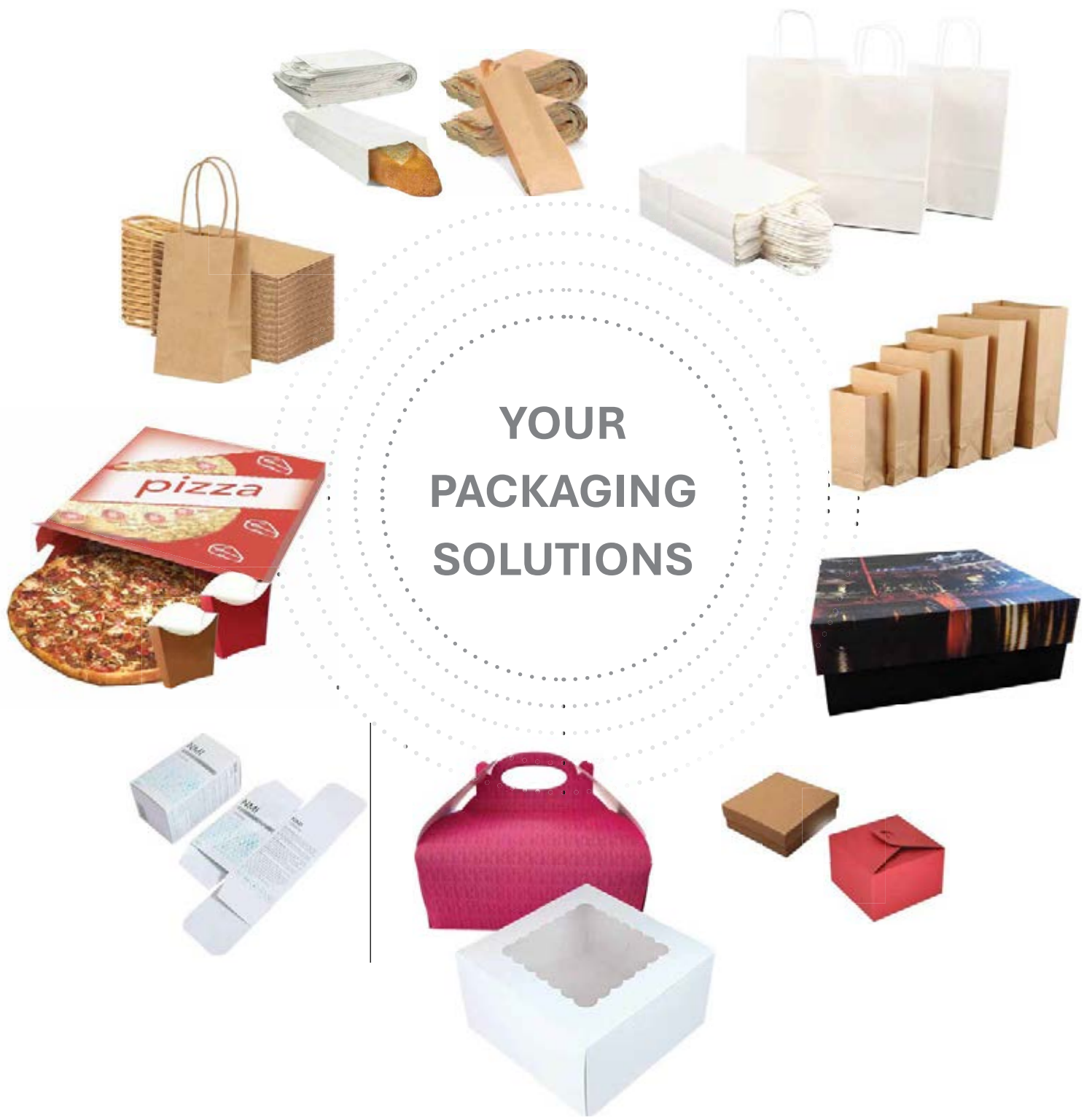

RULES OF ASSOCIATION Registration no. 5294

1. ESTABLISHMENT OF THE ASSOCIATION

- 1.1 There is established, in conformity with the Registration of Associations Act, the Chinese Business Chamber, hereinafter referred to as the association.
- 1.2 The association shall be a body corporate and shall have all the rights of a natural person and may engage in all such activities as may appear to it to be requisite, advantageous, convenient or conducive to the attainment of its objects.
- 1.3 The registered office of the association shall be situated at 17, David Street, Port Louis or at such other place as the board may determine. Operational office is situated at 1F TN Tower, 13 St Georges Street, Port Louis.

2. OBJECTS OF THE ASSOCIATION

The objects of the Association shall be to:

- 2.1 Promote interaction among business persons and professionals
- 2.2 Facilitate meetings between members and visiting business persons and professionals.
- 2.3 Promote activities, locally and overseas, for the benefit of the business and professional sectors.
- 2.4 Foster links and affiliation with other business and professional associations.
- 2.5 Represent the interests of its members vis-à-vis governmental and non-governmental authorities.

3. MEMBERSHIP

- 3.1 Membership of the association is open to business persons and professionals, aged 18 and over.
- 3.2 Membership applications shall be in writing and addressed to the secretary.
- 3.3 Membership applications shall be accepted or rejected by the board without giving any reason for its decision.
- 3.4 On admission, every member shall pay an entrance fee of one thousand rupees and an annual membership fee of one thousand rupees. A new member admitted after the month of June may be allowed to pay half the amount of the membership fee in respect of the current year.
- 3.5 Such fees may be varied by bye laws made by the board.

4. BOARD

- 4.1 The association shall be administered by the board which shall, subject to the Act, be vested with all the powers of the association.
- 4.2 The board shall consist of ten members. Board members shall be elected by the annual general meeting, as per paragraphs 4.3 and 4.4.
- 4.3 At each annual general meeting, half of the members of the board shall retire by order of seniority of their appointment but shall be eligible for re-election.
- 4.4 Until a rotation is properly established, the members of the board who shall retire shall be agreed among themselves or in absence of agreement, shall be designated by drawing of lots.
- 4.5 As soon as practicable after the annual general meeting, the members of the board shall elect among themselves the following officers:
 - President
 - Vice-President
 - Secretary
 - Assistant Secretary
 - Treasurer
 - Assistant Treasurer
- 4.6 No officer shall hold the same office on the board for more than two consecutive years.

5. BOARD MEETINGS

- 5.1 All Board meetings shall be chaired by the president and in his absence by the vice-president. In the absence of both the president and the vice-president, the members shall elect one among themselves to act as chairman for the meeting.
- 5.2 Five members of the board shall constitute a quorum.
- 5.3 All decisions of the board shall be taken by a simple majority of votes, each member present having one vote except the chairman who, in the event of equality of votes, shall have a second or casting vote.
- 5.4 The board shall meet quarterly. Additional meetings may be held whenever the president deems necessary and shall be held at the written request of not less than five members of the board.

6. FILLING OF VACANCY

- 6.1 Any member who is absent, without leave, from three consecutive meetings of the board shall be deemed to have resigned from the board on the date of the third meeting.
- 6.2 Whenever a vacancy occurs on the board, a member of the association shall, as soon as possible, be appointed by the board to fill the vacancy.
- 6.3 Where half the seats on the board are vacant at any time, the vacancies shall be filled by election at a special general meeting held within 30 days of the date of the last vacancy.
- 6.4 Any member appointed under paragraph 6.2 or 6.3, shall be deemed to stand in the shoes of the member he replaces and he shall retire from the Board on the expiry of the original mandate of the replaced member.

7. GENERAL MEETINGS

- 7.1 All general meetings shall be chaired by the president and in his absence by the vice-president. In the absence of both the president and the vice-president, the members shall elect one among themselves to act as chairman for the meeting.
- 7.2 Twenty members or in the absence thereof, one third of the number of members of the association, present in person or by proxy, shall constitute a quorum.
- 7.3 Subject to paragraphs 7.5 and 10.4 all decisions at general meetings shall be taken by a simple majority of members present in person on a show of hands.
- 7.4 The president may, whenever he deems necessary and shall, whenever requested in writing by ten members present in person, require a vote to be taken by ballot.
- 7.5 On a ballot each member present in person or by proxy shall have one vote.
- 7.6 In the event of equality of votes, either on a show of hands or on a ballot, the chairman shall have a second or casting vote.
- 7.7 Members owing more than one year's membership fees shall have no right of vote.
- 7.8 Only items appearing on the agenda shall be discussed at general meetings.

8. ANNUAL GENERAL MEETING

- 8.1 The first annual general meeting shall be held not later than 31st March 1999, and thereafter the annual general meeting shall be held not later than 31 March every year with the following agenda:
 - 8.1.1 The President's Report.
 - 8.1.2 The Treasurer's Report and Approval of Accounts.
 - 8.1.3 Election of Members of the Board.
 - 8.1.4 Appointment of Auditors.
 - 8.1.5 Approval of the Estimate of Expenditure
 - 8.1.6 Such other items as may be determined by the Board.

- 8.2 In the event there is no quorum at an annual general meeting fifteen minutes after the appointed time, the meeting shall stand adjourned to the same day in the next week at the same time and place, and any number of members present at the adjourned meeting shall constitute a quorum and such meeting shall be deemed to be validly constituted.

9. SPECIAL GENERAL MEETING

- 9.1 A special general meeting shall be convened:
- 9.1.1 not later than 21 days from the receipt of a written request by one tenth of the members of the association; and
 - 9.1.2 at such other times as the board shall think fit.
- 9.2 In the event there is no quorum at a special general meeting fifteen minutes after the appointed time, the meeting shall be dissolved absolutely.

10. REMOVAL OF MEMBERS

- 10.1 A member of the Association owing membership fees in respect of three years shall be deemed to have resigned and his name shall be removed from the list of members. Provided that at the discretion of the board, he may be readmitted as a member of the association on payment of the entrance fee together with the arrears of membership fees due by him.
- 10.2 Where by reason of his conduct or for any other cause, it is expedient that a member should cease to form part of the association, the board may after giving the member an opportunity to be heard, suspend or terminate his membership.
- 10.3 A decision of the board under paragraph 10.2 may be reversed by a special general meeting convened for that purpose at the request of the aggrieved member.
- 10.4 One or more members of the board may be removed from office by decision of two thirds of the members present in person or by proxy at a special general meeting convened for that purpose.

11. NOTICE OF MEETING

- 11.1 Unless otherwise decided by the board, five days' notice shall be required for the calling of board meetings.
- 11.2 Notice of general meetings shall be given fourteen days before the date appointed for the meeting.
- 11.3 The accidental omission to give notice of a meeting to or the non receipt of notice of a meeting by any person entitled to receive notice shall not invalidate the proceedings of that meeting.

12. THE PRESIDENT

- 12.1 The President shall:-
- 12.1.1 at all times promote the objects of the association and uphold its rules;
 - 12.1.2 chair and maintain order at all meetings and ensure that all items on the agenda are dealt with;
 - 12.1.3 submit to the annual general meeting a report on the activities of the association during his term of office.
- 12.2 In case of absence or inability to act of the president, he shall be replaced by the vice-president, who shall have the same duties and rights as the President.

13. THE SECRETARY

- 13.1 The Secretary shall:-
- 13.1.1 maintain an up to date register of members;

- 13.1.2 keep minutes of proceedings of all board meetings and general meetings of the association and ensure that such minutes are submitted for approval at subsequent meetings;
- 13.1.3 ensure that appropriate notice is given of all meetings;
- 13.1.4 be responsible for the submission of returns to the registrar of associations according to legal requirements.
- 13.2 In case of absence or inability to act of the Secretary, he shall be replaced by the assistant secretary, who shall have the same duties and rights as the secretary.

14. TREASURER

- 14.1 The treasurer shall:-
 - 14.1.1 keep proper accounting records of the affairs of the association;
 - 14.1.2 collect and give receipts for all funds, fees, contributions and moneys due to the Association and deposit them in banking accounts of the association or otherwise invest them with the approval of the board;
 - 14.1.3 make such payments as may be authorised by the board; all payments subject to the act and the regulations made thereunder are to be made by cheque;
 - 14.1.4 submit periodical statements of accounts as required by the board;
 - 14.1.5 submit for the approval of the annual general meeting, an audited statement of accounts for the preceding accounting period and report thereon;
 - 14.1.6 submit for the approval of the annual general meeting, an estimate of expenditure for the current year.
- 14.2 In case of absence or inability to act of the treasurer, he shall be replaced by the assistant treasurer, who shall have the same duties and rights as the treasurer.

15. AUDITORS

- 15.1 The annual general meeting shall appoint professional accountants as auditors and fix their remuneration, if any. The auditors may be removed and replaced by the members in general meeting.
- 15.2 No member of the board shall be appointed as auditor;
- 15.3 The auditors shall verify the books, accounts and records of the association at least once every year, and submit a report of their audit.

16. ACCOUNTING PERIOD

- 16.1 The accounting period of the association begins on the first day of January and ends on the thirty first day of December of every year.
- 16.2 Notwithstanding paragraph 16.1, the first accounting period of the association shall extend from the date of its registration to the thirty first day of December, 1998.

17. EXECUTION OF DOCUMENTS

- 17.1 Except as otherwise provided by these rules, all documents executed on behalf of the association, shall be signed jointly by the president and the secretary.
- 17.2 Cheques drawn on the banking accounts of the association shall be signed jointly by the president and the treasurer.
- 17.3 In case of absence or inability to act, the signatories may be replaced as follows: the president by the vice-president, the secretary by the assistant secretary and the treasurer by the assistant treasurer.
- 17.4 Notwithstanding the above, any document to which the association is a party, may be signed by any person or persons designated for that purpose by the board and when so signed, such document shall be deemed to have been duly executed by the association.

18. INSPECTION OF DOCUMENTS

All books, registers, accounts, records and documents of the association shall be open to inspection, at all reasonable times, on written application to the secretary, by any person having a legitimate interest in the affairs of the association.

19. LEGAL PROCEEDINGS

The association shall sue and be sued in its corporate name and service of any process shall be deemed to be sufficient, if made by or on the secretary.

20. BYE LAWS

- 20.1 The board shall have power to make bye laws for the proper running of the association.
- 20.2 Such bye laws shall be submitted to the next annual general meeting for ratification.
- 20.3 Notwithstanding paragraph 20.2, a bye law may provide that it shall enter into force pending its ratification and such bye law shall be binding on the association and its members unless and until it is canceled by the annual general meeting considering its ratification.
- 20.4 All acts, matters or things done by virtue of any bye law which is subsequently cancelled, shall be deemed to have been validly done, notwithstanding such cancellation and shall give rise to no refund, indemnity or any claim of whatever nature by or against the association.

21. DISPUTES

All disputes between the association and its members or any person in the rights of a member, as well as all disputes between members in relation to the affairs of the association shall be settled by a special general meeting convened for the purpose.

22. SECURITY BOND

- 22.1 The president, the vice-president, the treasurer and the assistant treasurer shall each become bound with two sureties in the sum of Rs 50,000 jointly and severally for the true performance of their duties.
- 22.2 The Security bonds shall be filed in the office of the Registrar of Association without undue delay

23. INVESTMENT OF FUNDS

The Board is empowered :

- (a) to invest the funds of the association in recognised securities;
- (b) to lease or to take on lease or to let moveable or immovable property; provided that the sanction of a General Meeting shall first be sought for any transaction that exceeds the amount provided for in the relevant law.
- (c) to accept donations and legacies from any source provided that such donations and legacies be free from any conditions detrimental to the objects of the association.

24. FINES AND FORFEITURES

No fines shall be imposed on any member for the late payment of their fees.

A member who resigns or who is expelled forfeits all his rights to any property of the association and to any contribution, monetary or otherwise, he may have made to the association.

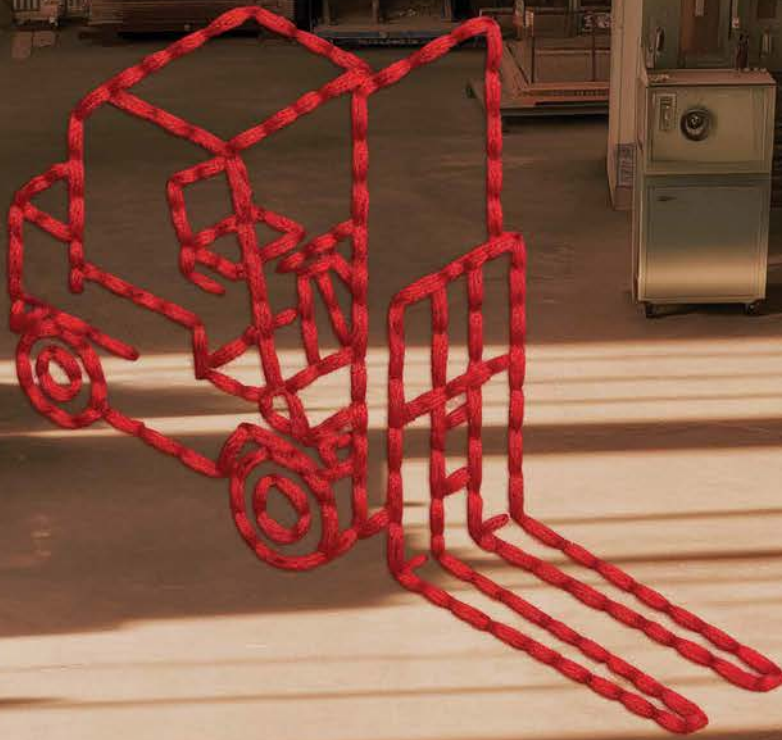
